### **Folk Bazaar Policy**

The Vancouver Folk Music Festival, in cooperation with the Parks Board and the City of Vancouver, will be accommodating vending on the outside of the festival grounds once again. The Folk Bazaar, located along the west fence of the festival grounds (beach-front), has quickly become a cherished part of the Festival experience. Submitting this application does not guarantee booth space in the Folk Bazaar.

Each application must be accompanied by a Visa or Mastercard number, or money order made out the Vancouver Folk Music Festival – we will not accept personal cheques.

### **Rental Information**

**Rules: No drugs or alcohol permitted, no animals on site, no parking provided, no water or power provided (no generators permitted), no open flames (ie. Candles), and no overnight camping.**

**By order of the Vancouver Parks Board, absolutely NO VEHICLES are allowed on site; booths must be hand loaded.**

**Space Size: 10 x 10 feet** (Vendor must provide their own tent.)

**Folk Bazaar Agreement 2012**

Letter of agreement between the Vancouver Folk Music Festival (“VFMF”)

AND

Hereinafter referred to as “the Vendor”.

Folk Bazaar agreement: All vendors are asked to adhere to the following list of protocols.

1. The vendor must pay a minimum of \$250: Visa, Mastercard and money order are accepted.
2. No drugs, alcohol, animals, or open flames are permitted within the Bazaar.
3. Food vendors are not permitted within the Bazaar.
4. Be advised that vending or soliciting outside the gated areas of the Bazaar and camping along Jericho Beach are prohibited by City By-Laws.
5. Parking will not be provided.
6. There will be no water or power provided. Generators are not permitted.
7. VFMF will not be held responsible for lost or stolen items, damage to property or a person. The vendor may wish to seek their own liability insurance.
8. All products and displays must be secured by the Vendor’s best efforts by 10PM Friday, Saturday, and Sunday evenings. Vendors will be granted access for set-up one hour before gates open. Security of this fenced in area will be provided. No persons will be allowed to remain within these gates after lock-down at 10 PM.
9. The Vendor must provide their own tents, tables, and chairs.
10. The Vendor must clean up and remove all waste from their booth space and assist with ensuring the Bazaar area is left clean during, and post, vending. Inability to comply may result in fines, discontinued contract, or rejection of future applications.
11. Exhibitors are required to supervise their own space during hours of operation.
